Wide Range of Cricket Trophy Awards Announced by Slazengers-S. McGown

As part of a drive to encourage and promote cricket this season, the manufacturers of S.M.G. Cricket Equipment have announced a further series of trophy awards. S.M.G. Trophies are available under four categories to players in Association and District Club matches.

Conditions:

(1) BOWLERS:

- (a) To bowlers, using S.M.G. or Stokes McGown brand Cricket Balls, taking 10 wickets in a competition match or 8 wickets in an innings; or
- (b) To bowlers performing the hat-trick.

Fullest details of the claimant's performance must be supplied and vouched for by the club secretary and an umpire or association secretary. Players are eligible for one award in each section—Bowlers, Wicketkeepers and Barsmen for the 1966-67 seasons.

To avoid fines the HOME CAPTAIN MUST phone results of each days play to the Honorary Recorder, Mr. D. Bray, 39 Arcadia Avenue, Gymea Bay, Phone 524-4979, Both Captains to post the result cards to the Recorder at the conclusion of the match, or be liable to a fine of One Dollar.

The home team will be responsible for the laying of the mats, and the returning of same to its place of storage. It is the responsibility of the HOME team to maintain and care for the wicket area.

ONLY A1 Grade players may register on the field of play, other Grades may request, through the Secretary, permission to play, on a three match performance basis, where final acceptance will be granted by the Executive, it will be the duty of the club making the request, to supply the Executive with the necessary performances.

Also supply the Registration Fee of One Dollar, name and addresses at the following Delegates meeting, or be liable to suspension until such requests are met.

The Recorder requires clubs to ring results of each days play on Saturday from 7.00 p.m. to 9.00 p.m. and Sunday mornings from 9.00 a.m. to 10.00 a.m., do not ask results, give them.



Sutherland Shire Cricket Umpires' Association

Quite some years back, a group of ardent cricket enthusiasts, living within the boundaries of the Sutherland Shire, formed a cricket association supplementary to the main body and which became known as the "Sutherland Shire Cricket Association Boys' Competition".

Within a short space of time and closely related to the growth of the Shire this new unit grew to the point where it became increasingly apparent that some effort would need to be made to teach these youngsters something more than the basic principles of the game.

Further, it soon became obvious that something also would have to be done to assist those dedicated people who were so freely giving of their time and energy in managing and coaching these young teams, plus scoring and umpiring for them—people who perhaps had not played the game for several years and had become a bit "rusty" on the rules of the game, or who had only a passing knowledge of its laws.

Headed by Jim Daly, so well-known to every cricketer in the Sutherland Shire, and supported by stalwarts such as Wally Croucher, George Merritt, Eric Hilzinger, Rex King, Jack Moodie, the Sutherland Shire Cricket Association Boys' Competition Umpires' Association was duly formed. Affiliation with New South Wales Cricket Umpires' Association followed, umpire training schools were commenced, examinations, were held and soon a small number of official umpires were available for important matches and further training of team coaches and managers who, it was hoped, would form the nucleus around which a greater knowledge and appreciation of the game within the ranks of the Boys' Association would eventuate.

History records how successful this was. Inter-District Boys' Teams were being supported in the field by their own fully trained official umpires; more and more officials were offering themselves for training; they in turn were passing better knowledge of the laws and rules of the game to the young players in their charge and, all in all, a most happy situation was developing.

Towards the latter end of 1964 the executive of the Boys' Cricket Umpires' Association began consideration of a Constitution and the formation of a more extensive and complete administrative arrangement. About this time also Mr. Rex King, Secretary of the Sutherland Shire Cricket Association, addressed a meeting of Boys' Association delegates with a suggestion that qualified umpires within its ranks make themselves available for senior matches.

In early 1965, therefore, a committee spent much time in developing a constitution which incorporated the appointment of umpires for any and every cricket match conducted by either the S.S.C.A. or the Boy's Association.

This was finally presented and adopted on 23rd June, 1965, and presented at the first annual meeting in July where it was adopted and a full complement of office bearers, examination and appointment boards elected.

As could be expected, the first few months produced problems, but bit by bit, they were resolved to the point where today we have a financial membership list of 60 which is gradually growing (but not quickly enough).

To give some idea of the number of umpires required in an active capacity to enable adequate representation at cricket matches played within the Shire, the senior body has 44 cricket teams, which requires 44 umpires every Saturday afternoon. There are also both men's and boys' inter-district series of matches for which umpires are a "must".

Under our Constitution, in recognition of the problems confronting many of our members, it is not compulsory for members to officiate upon demand as in the New South Wales Cricket Umpires Association — in fact, members are permitted to nominate their availability or otherwise virtually match by match and it is usual for only 16 members to be available for any one round.

It is our intention that during the 1966/67 Cricket Season we will be conducting two Umpire Training Schools. Also there will be a number of organised lectures, showing of films and other social activities concerning which separate invitations will be extended.

These activities, plus the advent of the normal enthusiast who fortunately seems to appear upon the scene periodically, will, we hope, increase our membership quickly to the point where we are able to provide at least one umpire at each official cricket match within the Shire. Remember — to offset out-of-pocket expenses incurred in purchasing boots, coats, hats plus costs of transport and other incidentals — umpires are paid currently at the rate of \$2.00 per half day match or \$4.00 if taking both ends.

For those cricketers who aspire ultimately to officiate at grade, interstate and test matches, membership of the Sutherland Shire Cricket Umpires' Association is a most positive step in this direction. Some of our members are already New South Wales Cricket Association Umpires.

It may be interesting to cricketers to know that our Association meets on the second Wednesday night of each month at 8 p.m. at the Port Hacking Businessmen's Club, where not only members, but visitors, are most welcome.

⁵ Meetings consist of the usual formalities, which we try to dispose of in a reasonably short space of time so that as complete a discussion as possible can take place concerning any contentious rule or law of cricket, with emphasis on experimental laws introduced from time to time. I am sure every cricketer or intending umpire would find these discussions most interesting.

Meetings close no later than 10 p.m. and the facilities of the Club are available to all for the rest of the evening.

Please feel welcome to come along on any of these nights.

As it exists today, the Sutherland Shire Cricket Umpires' Association: Is fully constituted,

Is affiliated with the N.S.W. Cricket Umpires' Association,

Has adopted its own badge and tie,

Is a virile growing organisation,

Has provision for both active and associate members,

Has, as its aims and objectives, the greater knowledge of cricket within the Shire on the part of those who play the game, together with the never-ending desire to project uniformity of interpretation of the laws of cricket where the game is played.

Our efforts and appearance were very favourably commented upon during the 1965-66 Inter-District series of cricket matches. In fact, we were the only Association to provide a full complement of officials for all matches and our interpretations, demeanour, and control of games generally was considered of the highest standard.







THE LAWS OF CRICKET AND **COMPETITION BY-LAWS**

of the SUTHERLAND SHIRE CRICKET ASSOCIATION

THE LAWS OF CRICKET

(a) The Players, Umpires and Scorers SIDES

1.-A match is played between two sides of eleven players each, unless otherwise agreed. Each side shall play under a Captain who, before the toss for innings, shall nominate his players who may not thereafter be changed without the consent of the opposing Captain. Notes

- 1. If a captain is not available at any time, a deputy must act for him to deal promptly with points arising from this and other laws.
- 2. No match in which more than eleven players a side take part can be regarded as first class, and in any case no side should field with more than eleven nor less than six (6) registered players.

SUBSTITUTES

2.-- A substitute shall be allowed to field or run between the wickets for any player who may during the match be incapacitated from illness or injury, but not for any other reason without the consent of the opposing captain: no substitute shall be allowed to bat or bowl. Consent as to the person to act as substitute in the field shall be obtained from the opposing captain, who may indicate positions in which the substitute shall not field. Notes

- 1. A player may bat, bowl or field even though a substitute has acted for him previously.
- 2. An injured batsman may be "out" should his runner infringe Laws 36, 40 or 41. As striker he remains himself subject to the laws; should he be out of his ground for any purpose he may be "out" under Laws 41 and 42 at the wicketkeeper's end, irrespective of the position of the other batsman or the substitute when the wicket is put down. When not the striker the injured batsman is out of the game and stands where he does not interfere with the play.
- 3. No team shall be allowed more than three (3) substitutes in the field. THE APPOINTMENT OF UMPIRES

3.-Before the toss for innings, two umpires shall be appointed, one for each end to control the game as required by the Laws with absolute impartiality. No umpire shall be changed during a match without the consent of both captains.

Notes

1. Umpires shall be appointed by the Umpires Appointment Board. In the event of umpires being absent the appointment of others to take their place shall be vested in the captains of the teams concerned; if they fail to agree, an Officer of the Association shall make the appointment and his decision shall be final.

- When matches are completed on the first day the Appointments Board shall have power to appoint umpires to any other match on the second day where only one umpire has been appointed.
- 3. No umpire shall be transferable to a match where there is no official umpire in attendance.

THE SCORERS

4.—All runs scored shall be recorded by Scorers appointed for the purpose; the Scorers shall accept and acknowledge all instructions and signals given to them by the Umpires.

Note

- 1. The Umpires should wait until a signal has been answered by a scorer before allowing the game to proceed. Mutual consultation between
- the scorers and the umpires to clear up doubtful points is at all times permissible.

(b) The Implements of the Game and the Ground

THE BALL

5.—The ball shall weigh not less than 54 ounces, nor more than 54 ounces. It shall measure not less than 811 inches, nor more than 9 inches in circumference. Subject to agreement to the contrary, either Captain may demand a new ball at the start of each innings. In the event of the ball being lost or in the opinion of the Umpires becoming unfit for play, the Umpires shall allow another ball to be taken into use. They shall inform the batsmen whenever a ball is to be changed.

Notes

- The type of ball to be used in Association competition matches shall be as approved by the Association but shall be provided by each team who all have replacement in readiness.
- After 200 runs have been scored off a ball the Captain of the fielding side shall have the right to use a new ball.
- 3. A ball substituted for one lost or becoming unfit for play shall be as similar in condition as practicable to the one previously in use and for the purpose of Note 2 shall be regarded as the same ball.
- 4. The ball in play at the conclusion of the first day's play shall be initialled by the Umpires who shall satisfy themselves on the recommencement of play that the ball produced conforms to the conditions laid down.

THE BAT

6.—The bat shall not exceed 41 inches in the widest part; it shall not be more than 38 inches in length.

THE PITCH

7.—The pitch is deemed to be the area of ground between the bowling creases, 5 feet in width on either side of the line joining the centre of the wickets. Before the toss for innings, the executive of the ground shall be responsible for the selection and preparation of the pitch; thereafter the Umpires shall control its use and maintenance. The pitch; thereafter the changed during a match unless it becomes unfit for play, and then only with the consent of both Captains. Where canvas or coir matting or malthoid or some similar material is used on a pitch made of concrete or any other hard base, the width of such artificial covering shall be regarded as the width of the "pitch" and any ball bowled and pitching off such covering on either side of it shall be held to be a "No Ball" and the Umpire shall call and signal "No Ball" immediately the ball so pitches.

THE WICKETS

8.—The wickets shall be pitched opposite and parallel to each other at a distance of 22 yards from stump to stump. Each wicket shall be 9

inches in width and consist of three stumps with two bails upon the top. The stumps shall be of equal and sufficient size to prevent the ball from passing through, with their top 28 inches above the ground. The bails shall each be $4\frac{3}{2}$ inches in length, and, when in position on the top of the stumps, shall not project more than $\frac{1}{2}$ inch above them.

Notes

- 1. Except for the bail grooves the top of the stumps shall be domeshaped.
- In a high wind the captains may agree, with the approval of the umpires, to dispense with the use of the bail (see Law 31, Note 3).

THE BOWLING AND POPPING CREASES

9.—The bowling crease shall be in line with the stumps; 8 feet 8 inches in length; the stumps in the centre; with a return crease at each end at right angles behind the wicket. The popping crease shall be marked 4 feet in front of and parallel with the bowling crease. Both the return and popping creases shall be deemed unlimited in length. Note

 The distance of the popping crease from the wicket is measured from a line running through the centre of the stumps to the inside edge of the crease.

(c) The Care and Maintenance of the Pitch

ROLLING, MOWING AND WATERING

10.—Unless permitted by special regulations, the pitch shall not be rolled during a match except before the start of each innings and of each day's play, when, if the captain of the batting side so elect, it may be swept and rolled for not more than seven minutes. The pitch shall not be mown during a match unless special regulations so provide. Under no circumstances shall the pitch be watered during a match. Where a match is played on a matting or malthoid wicket the matting may be taken up, and the concrete or malthoid surface of the wicket may be swept during the progress of the game at the discretion of the captain or, if they disagree, of the umpires.

Notes

- "Special Regulations", within the framework of the Laws, referred to in this and subsequent Laws are those authorised by M.C.C. in respect of County Cricket, or by Overseas Governing Bodies in respect of cricket in the countries concerned. Such regulations do not apply to matches played by touring teams unless included in these Notes and Interpretations of the Official Laws, or unless agreed to by both parties before the visting team arrives.
- The umpires are responsible that any rolling permitted by this Law and carried out at the request of the captain of the batting side is in accordance with the regulations laid down and that it is completed so as to allow play to start at the stipulated time.

The normal rolling before the start of each day's play shall take place not earlier than half an hour before the start of play, but the captain of the batting side may delay such rolling until 10 minutes before the start of play should he so desire.

3. The time allowed for rolling shall be taken out of the normal playing time if a captain declare an innings closed either (a) before play starts on any day so late that the other captain is prevented from exercising his option in regard to rolling under this Law, or (b) during the luncheon interval later than 15 minutes after the start of such interval.

- 4. In Australia, South Africa, the West Indies, and New Zealand, if at any time a rain-affected pitch is damaged by play thereon, it shall be swept and rolled for a period of not more than ten consecutive minutes at any time between the close of play on the day on which it was damaged and the next resumption of play, provided that:---
 - (i) The umpires shall instruct the groundsman to sweep and roll the pitch only after they have agreed that damage caused to it as a result of play after rain has fallen warrants such rolling additional to that provided for in Law 10.
 - (ii) Such rolling shall in all cases be done under personal supervision of both umpires and shall take place at such time and with such roller as the groundsman shall consider best calculated to repair the damage to the pitch.
 - (iii) Not more than one such additional rolling shall be permitted as a result of rain on any particular day.(iv) The rolling provided for in Law 10, to take place before the start
 - (iv) The rolling provided for in Law 10, to take place before the start of play, shall not be permitted on any day on which the rolling herein provided for takes place within two hours of the time appointed for commencement of play on that day.
- 5. The pitch shall be mown under the supervision of the umpires before play begins on alternate days after start of a match, but should the pitch not be so mown on any day on acocunt of play not taking place, it shall be mown on the first day on which the match is resumed thereafter on alternate days. (For the purpose of this rule a rest day counts as a day.)

COVERING THE PITCH

11.—The pitch shall not be completely covered during a match unless special regulations so provide; covers used to protect the bowler's run-up shall not extend to a greater distance than 3½ feet in front of the popping creases.

Note

 It is usual under this Law to protect the bowler's run up before and during a match, both at night and, when necessary, during the day. The covers should be removed early each morning, if fine.

MAINTENANCE OF PITCH

12.—The batsman may beat the pitch with his bat, and players may secure their footholds by the use of sawdust, provided Law 46 be not thereby contravened. In wet weather the unpires shall see that the holes made by the bowlers and batsmen are cleaned out and dried whenever necessary to facilitate play.

(d) The Conduct of the Game

INNINGS

13.—Each side has two innings, taken alternatively, except in the case provided for in Law 14. The choice of innings shall be decided by tossing on the field of play. There shall be an interval of ten (10) minutes between innings.

Notes

- The winner of the toss may not alter his decision to bat or field once it has been notified to the opposing captain.
- This Law also governs a one-day match in which play continues after the completion of the first innings of both sides. (See also Law 22.)
- 3. If a team has batted full time on the first day it shall not continue to bat on the second except if time was lost due to wet weather, when such team may continue to bat on the second for a length of time not exceeding half of that lost on the first day. If no play takes place on

the first day the first innings on the second day shall not continue longer than half the time remaining for play.

FOLLOWING INNINGS

14.—The side which bats first and leads by 150 runs in a match of three days or more, by 100 runs in a two-day match, or by 75 runs in a one-day match, shall have the option of requiring the other side to follow their innings.

Note

 For the purpose of this Law a match played on two separate afternoons shall be regarded as a one-day match.

DECLARATIONS

15.—In a two-day match or a one-day match or a match played on two separate afternoons or a match played on one afternoon, the captain of the side to bat first shall not declare the innings closed until the side has batted for at least one hour.

Subject to any domestic rule on the matter, the captain of the side batting first in a two-day match or a match played on two separate afternoons shall not declare that innings closed on the first afternoon later than one hour and ten minutes before the time agreed upon for drawing stumps.

16.—When the start of play is delayed by weather, Law 14 shall apply in accordance with the number of day's play remaining from the actual start of the match.

START AND CLOSE OF PLAY AND INTERVALS

17.—The Umpires shall allow such intervals as have been agreed upon for meals, 10 minutes between each innings and not more than two minutes for each fresh batsman to come in. At the start of each innings and of each day's play and at the end of any interval the umpire at the bowler's end shall call "play", and the side refusing to play shall lose the match. After "play" has been called no trial ball shall be allowed to any player, and when one of the batsmen is out, the use of the bat shall not be allowed to any player until the next batsman shall come in.

Notes

- The umpires shall not award a match under this law unless: (i) "play" has been called in such a manner that both sides can clearly understand that play is to start; (ii) an appeal has been made; and (iii) they are satisfied that a side will not or cannot continue play.
- 2. It is an essential duty of the captains to ensure that the "ingoing" batsman passes the "outgoing" one before the latter leaves the field of play. This is all the more important in view of the responsibility resting on the umpires for the deciding whether or not the delay of the individual amounts to a refusal of the batting side to contine play.
- 3. The interval for luncheon should not exceed 45 minutes unless otherwise agreed (but see Law 10, Note 3). In the event of the last wicket falling within two minutes of the time arranged for luncheon or tea, the game shall be resumed at the usual hour, no allowance being made for the 10 minutes between the innings.
- Bowling practice on the pitch is forbidden at any time during the game.

18.—The umpires shall call "time" and, at the same time, remove the bails from both wickets on the cessation of play before an arranged interval, at the end of a day's play, and at the conclusion of the match. Subject to any domestic Association rule on the point an "over" shall always be started if "time" has not been reached and shall be completed unless a wicket fall within two (2) minutes of "time". The incoming batsman may claim the right to bat for the time remaining. If a wicket falls after "time" has been reached the umpires shall call "time".

SCORING

19.—The score shall be reckoned by runs. A run is scored: first, so often as the batsmen, after a hit, or at any time while the ball is in play shall have crossed and made good their ground from end to end, but if either batsman run a short run, the umpire shall call and signal "one short" and that run shall not be scored. The striker being caught, no run shall be scored; a batsman being run out, that run which was being attempted shall not be scored; second, for penalties under Laws 21, 27, 29, 44 and boundary allowances under Law 20.

Notes

1. If while the ball is in play, the batsmen have crossed in running, neither returns to the wicket he has left except in the case of a boundary hit,

or under Laws 40, Note 1 and 46, Note 4 (iv). This rule applies even should a short run have been called, or should no run be reckoned as in the case of a catch.

2. A run is "short" if either, or both, batsmen fail to make good their ground in turning for a further run.

Although such a "short" run shortens the succeeding one, the latter, if completed, counts. Similarly, a batsman taking stance in front of his crease may run from that point without penalty.

- of his crease may run from that point without penalty. 3. (i) One run only is deducted if both batsmen are short in one and the same run.
 - (ii) Only if three or more runs are attempted can more than one run be "short" and then, subject to (i) above, all runs so called shall be disallowed.
- 4. An umpire signals "short" runs when the ball becomes "dead" by bending his arm upwards to touch the shoulder with the tips of his fingers. If there has been more than one "short" run the umpires must instruct the scorers as to the number of runs disallowed. (See Note 1 to Law 4.)

BOUNDARIES

20.—Before the toss for innings the umpires all agree with both sides on the boundaries for play, and on the allowances to be made for them. An umpire shall call or signal "boundary" whenever, in his opinion, a ball in play hits, crosses or is carried over the boundary shall count only should they exceed the allowance. If the boundary result from an overthrow any runs already scored at the instant of the throw and the allowance shall be added to the score, but if the boundary result from the wilful act of a fieldsman the run in progress shall also count if the batsmen have crossed at the instant of the act and shall be added to the score in addition to the runs already scored and the allowance.

Notes

- If flags or posts are used to mark a boundary, the real or imaginary line joining such points shall be regarded as the boundary, which should be marked by a white line if possible.
- 2. In deciding on the allowances to be made for boundaries the umpires will be guided by the prevailing custom of the ground.
- 3. It is a "boundary" if the ball touches any boundary line or if a fieldsman with the ball in hand grounds any part of his person on or over that line. A fieldsman, however, standing within the playing area may lean against or touch a boundary fence in fielding a ball. (See also Law 35, Note 5.) The boundary line shall be imaginary straight lines between boundary flags placed by home team at a distance not exceeding fifty feet from each other or by any other defined boundary previously approved by the executive.

- 4. An obstacle, or person, within the playing area is not regarded as a boundary unless so arranged by the umpires. The umpire is not a boundary, but sight screens within the playing area shall be so regarded.
- 5. The customary allowances for a boundary is 4 runs, but it is usual to allow 6 runs for all hits pitching over and clear of the boundary line or fence (even though the ball has been previously touched by a fieldsman). It is not usual to allow 6 runs when a ball hits a sight screen full pitch, if the latter is inside the boundary.
- 6. The allowances of six runs referred to in Note 5 of this Law where a boundary is defined by a picket or similar-type fence.
- 7. The umpire signals "boundary" by waving an arm from side to side, or a "boundary" six by raising both arms above the head.

LOST BALL

21.-If a ball in play cannot be found or recovered any fieldsman may call "Lost Ball" when 6 runs shall be added to the score; but if more than 6 runs have been run before "Lost Ball" be called, as many runs as have been run shall be scored.

THE RESULT

22.-- A match is won by the side which shall have scored a total of runs in excess of that scored by the opposing side in its two completed innings; one-day matches, unless thus played out, shall be decided by the first innings. A match may also be determined by being given up as lost by one of the sides, or in the case governed by Law 17. A match not determined in any of these ways, shall count as a "Draw" or "Tie".

Notes

- 1. It is the responsibility of the captains to satisfy themselves on the correctness of the scores on the conclusion of play.
- 2. Neither side can be compelled to continue after a match is finished; a one-day match shall not be regarded as finished on the result of the first innings if the umpires consider there is a prospect of carrying the game any further issue in the time remaining.
- 3. The result of a finished match is stated as a win by runs, except in the case of a win by the side batting last, when it is by the number of wickets still then to fall. In a one-day match which is not played out on the second innings, this rule applies to the position at the time when a result on the first innings was reached.
- 4. In a played-out match it is a "tie" when the total number of runs scored by the side leading on the first innings in its two completed innings is equalled at the final cessation of play by the total of runs scored by the opposing side irrespective of the number of wickets which such opposing side may then have lost.

In a match not played-out it is a "tie" on the first innings when an equal number of runs shall have been scored by each side for a completed first innings provided no further result has obtained in the second innings.

THE OVER

23 .- The ball shall be bowled from each wicket alternatively in overs of either 8 or 6 balls according to the agreed conditions of play. When the agreed number have been bowled and it has become clear to the umpire at the bowler's wicket that both sides have ceased to regard the ball as in play, the umpire shall call "over" in a distinct manner before leaving the wicket. Neither a "no ball" nor a "wide ball" shall be reckoned as one of the "over".

Notes

- 1. Subject to the other conditions of this Law an "over" shall be considered eight balls.
- 2. In matches arranged by this Association, the Executive shall, in particular circumstances, be empowered to direct that consecutive overs shall be bowled from the same wicket.

24 .-- A bowler shall finish an "over" in progress unless he be incapacitated or be suspended for unfair play. He shall be allowed to change ends as often as desired provided only that he shall not bowl two "overs" consecutively in one innings. A bowler may require the batsman at the wicket from which he is bowling to stand on whichever side of it he may direct.

DEAD BALL

25 .- The ball shall be held to be "dead"-on being, in the opinion of the umpire, finally settled in the hands of the wicketkeeper or of the bowler; or on reaching or pitching over the boundary; or, whether played or not, on lodging in the dress of either a batsman or umpire; or on the call of "over" or "time" by the umpire; or on a batsman being out from any cause; or on any penalty being awarded under Laws 21 or 44. The Umpire shall call "Dead Ball" should he decide to intervene under Law 46 in a case of unfair play or in the event of a serious injury to a player; or should he require to suspend play prior to the striker receiving a delivery; the umpire shall signal a "Dead Ball" by crossing his arms. The ball shall cease to be "dead" on the bowler starting his run or bowling action.

Notes

- 1. Whether the ball is "finally settled" is a question of fact for the umpire alone to decide.
- 2. An umpire is justified in suspending play prior to the striker receiving a delivery in any of the following circumstances:---
 - (i) If satisfied that, for an adequate reason, the striker is not ready to receive the ball and makes no attempt to play it,
 - (ii) If the bowler drops the ball accidentally before delivery, or if the ball does not leave his hand for some reason.
 - (iii) If one or both bails fall from the striker's wicket before he receives the delivery.

In such cases the ball is regarded as "dead" from the time it last came into play.

- 3. A ball does not become "dead" when it strikes an umpire (unless it lodges in his dress), when the wicket is broken or struck down (unless a batsman is out thereby), or when an unsuccessful appeal is made.
- 4. For the purpose of this and other Laws, the term "dress" includes the equipment and clothing of players and umpires as normally worn.

NO BALL

26 .- For a delivery to be fair the ball must be bowled, not thrown or jerked; if either umpire be not entirely satisfied of the absolute fairness of a delivery in this respect, he shall cal land signal "no ball" instantly upon delivery. The umpire at the bowler's wicket shall call and signal "no ball" if he is not satisfied that at the instant of delivery the bowler has at least some part of one foot behind the bowling crease and within the return crease, and not touching or grounded over either crease.

Notes

- 1. Subject to the provisions of the Law being complied with, a bowler is not debarred from delivering the ball with both feet behind the bowling crease.
- 2. The striker is entitled to know whether the bowler intends to bowl over or round the wicket, overarm or underarm, right or left handed. An umpire may regard any failure to notify a change in the mode of delivery as "unfair". If so, he should call "no ball"
- 3. It is a "no ball" if the bowler, before delivering a ball, throws it at the striker's wicket even in an attempt to run him out. (See Law 46, Note 4 (vii).)
- If a bowler break the near wicket with any part of his person during 4 the delivery, such act in itself does not constitute "no ball".
- The umpire signals "no ball' by extending one arm horizontally.
- 6. An umpire should revoke the call "no ball" if the ball does not leave the bowler's hand for any reason.

27 .- "The ball does not become "dead" on the call of "no ball". The striker may hit a "no ball" and whatever runs result shall be added to his score, but runs made otherwise from a "no ball" shall be scored "no balls", and if no runs be made one run shall be so scored. The striker shall be out from a "no ball" if he break Law 37, and either batsman may be run out, or given out if he break Laws 36 or 40.

Notes

- 1. The penalty for a "no ball" is only scored if no runs result otherwise.
- Law 46, Note 4 (vii) covers attempts to run before the ball is delivered, but should the non-striker unfairly leave his ground too soon, the fielding side may run out the bastman at the bowler's end by any recognised method. If the bowler throws at the near wicket, the umpire does not call "no ball", though any runs resulting are so scored. The throw does not count in the "over".

WIDE BALL

28 .- If the bowler shall bowl the ball so high over or so wide of the wicket that in the opinion of the umpire it passes out of the reach of the striker, and would not have been within his reach when taking guard in the normal position, the umpire shall call and signal "wide ball" as soon as it shall have passed the striker.

- Notes
- 1. If a ball which the umpire considers to have been delivered comes to rest in front of the striker, "wide ball" should not be called, and no runs should be added to the score unless they result from the striker hitting the ball which he has a right to do without interference by the fielding side.
- 2. The umpire signals "wide" by extending both arms horizontally,
- An umpire should revoke the call if the striker hits a ball which has been called "wide"
- 4. In this Association a wide ball pitched off the matting on either side of the wicket shall be regarded as a "no ball".

29 .- The ball does not become "dead" on the call of "wide ball". All runs that are run from a "wide ball" shall be scored "wide balls", or if no runs are made one run shall be scored. The striker may be out from a "wide ball' if he break Law 38 or 42, and either batsman may be run out, or given out, if he break Laws 36 and 40.

BYE AND LEG BYE

30 .- If the ball, not having been called "wide" or "no ball" pass the striker without touching his bat or person, and any runs be obtained, the Compliments of .

umpire shall call or signal "bye"; but if the ball touch any part of the striker's dress or person except his hand holding the bat, and any run be obtained, the umpire shall call or signal "leg bye"; such runs to be scored "byes" and "leg byes" respectively.

Notes

- 1. Leg byes which result from the unintentional deflection of the ball by any part of the striker's person other than the hand holding the bat, whether he has played at the ball or not, are fair. If the umpire is not entirely satisfied that the act was unintentional, he shall call "dead ball" as soon as he sees that the fielding side have no chance of dismissing either batsman as an immediate result of such deflection.
- 2. The umpire signals "bye" by raising an open hand above the head, and "leg bye' by touching a raised knee with the hand.

THE WICKET IS DOWN

31.-The wicket shall be held to be "down" if either the ball or the striker's person completely removes either bail from the top of the stumps or, if both bails be off. Any player may use his hand or arm to put the wicket down or, even should the bails be previously off, may pull up a stump, provided always that the ball is held in the hand or hands so used. Notes

- 1. A wicket is not "down" merely on account of the disturbance of a bail, but it is "down" if a bail, in falling from the wicket, lodges between two of the stumps.
- 2. If one bail is off, it is sufficient for the purpose of this Law to dislodge the remaining one in any of the ways stated or to strike any of the three stumps out of the ground.
- 3. If, owing to the strength of the wind, the captains have agreed to dispense with the use of the bails (see Law 8, Note 2,) the decision as to when the wicket is "down" is one for the umpires to decide the facts before them. In such circumstances the wicket would be held to be "down" even though a stump has not been struck out of the ground.
- 4. If the wicket is broken while the ball is in play, it is not the umpire's duty to remake the wicket until the ball has become "dead". A fieldsman, however, may remake the wicket in such circumstances.
- 5. For the purpose of this and other Laws the term "person" includes a player's dress as defined in Law 25. Note 4.

OUT OF HIS GROUND

32 .- A batsman shall be held to be "out of his ground" unless some part of his bat in hand or of his person be grounded behind the line of the popping crease.

BATSMAN RETIRING

33.-A batsman may retire at any time, but may not resume his innings without the consent of the opposing captain, and then only on the fall of a wicket.

Note

1. When a batsman has retired owing to illness, injury or some other unavoidable cause, his innings is recorded as "retired, not out", but otherwise as a completed innings to be recorded as "retired, out".

BOWLED

34.-The striker is out "bowled" if the wicket be bowled down, even if the ball first touch his bat or person.

Notes

1. The striker, after playing at the ball, is out "bowled" if he then kicks or hits it on to his wicket before the completion of his stroke. 41

* Wool -- Haberdashery * Gifts for all occasions * Toys for the kiddies

 The striker is out "bowled" under this Law when the ball is deflected on to his wicket off his person, even though a decision against him might be justified under Law 39 L.B.W.

CAUGHT

35.—The striker is out "caught"—if the ball, from a stroke of the bat or of the hand holding the bat, but not the wrist, be held by a fieldsman before it touches the ground, although it be hugged to the body of the catcher, or be accidentally lodged in his dress. The fieldsman must have both his feet entirely within the playing area at the instant the catch is completed.

Notes

- Provided the ball does not touch the ground, the hand holding it may do so in effecting a catch.
- The umpire is justified in disregarding the fact that the ball has touched the ground, or has been carried over the boundary, provided that a catch has in fact been completed prior to such occurrence.
- The fact that the ball has louched the striker's person before or after touching his bat does not invalidate a catch.
- 4. The striker may be "caught" even if the fieldsman has not touched the ball with his hands, including the case of a ball lodging in the wicketkeeper's pads.
- 5. A fieldsman standing within the playing area may lean against the boundary to catch a ball, and this may be done even if the ball has passed over the boundary.
- 6. If the striker lawfully plays the ball a second time he may be out under this law, but only if the ball has not touched the ground, since being first struck.
- The striker may be caught off any obstruction within the playing area provided it has not previously been decided on as a boundary.

HANDLED THE BALL

36.—Either batsman is out "bandled the ball"—if he touch it while in play with his hands, unless it be done at the request of the opposite side, provided the umpire considers (on appeal) that such offence warrants that decision.

Notes

- A hand holding the bat is regarded as part of it for the purpose of Laws 36, 27 and 39.
- The correct entry in the score book when a batsmen is given out under this Law is "handled the ball", and the bowler does not get the credit for the wicket.

HIT THE BALL TWICE

37.—The striker is out "hit the ball twice"—if the ball be struck or be stopped by any part of his person and he wilfully strike it again, except for the sole purpose of guarding his wicket, which he may do with his bat or any part of his person, other than his hands. No runs, except those which may result from an overthrow, shall be scored from a ball lawfully struck twice.

Notes

 It is for the umpire to decide whether the ball has been so struck a second time legitimately or not. The umpire may regard the fact that a run is attempted as evidence of the batsmen's intention to take advantage of the second stroke, but it is not conclusive.

- A batsman may not attempt to hit the ball twice, if in so doing he baulks the wicketkeeper or any fieldsman attempting to make a catch.
- This Law is infringed if the striker, after playing the ball and without any request from the opposite side, uses his bat to return the ball to a fieldsman.
- The correct entry in the scorebook when the striker is given out under this Law is "hit the ball twice", and the bowler does not get the credit for the wicket.

HIF WICKET

38.—The striker is out "hit wicket"—if, in playing at the ball, he hit down the wicket with his bat or any part of his person.

Notes

- 1. The striker is out under this Law if :---
 - (i) In making a second stroke to keep the ball out of his wicket he hits it down.
 - (ii) While playing at the ball, but not otherwise, his wicket is broken by his cap or hat falling, or by part of his bat. For the purpose of this Note a lawful second stroke, under Law 37, is not regarded as "playing at the ball".
- A batsman is not out for breaking his wicket with his bat or person while in the act of running.

L.B.W.

39.—The Striker is out "leg before wicket"—If, with any part of his person except his hand, which is in a straight line between wicket and wicket, even though the point of impact be above the level of the bails, he intercept a ball which has not first touched his bat or hand, and which, in the opinion of the umpire, shall have, or would have, pitched on a straight line from the bowler's wicket to the striker's wicket, or shall have pitched on the off-side of the striker's wicket, provided always that the ball would have hit the wicket.

Notes

- The word "hand" used in this Law should be interpreted as the hand holding the bat.
- A batsman is only "out" under this Law if all the four following questions are answered in the affirmative.
 - (i) Would the ball have hit the wicket?
 - (ii) Did the ball pitch in a straight line between wicket and wicket (and this case includes a ball intercepted full pitch by the striker), or did it pitch on the off side of the striker's wicket?
 - (iii) Was it part of the striker's person other than the hand which first intercepted the ball?
 - (iv) Was that part of the striker's person in a straight line between wicket and wicket at the moment of impact, irrespective of the beight of the point of impact?

OBSTRUCTING THE FIELD

40.—Either bastman is out "obstructing the field"— if he wilfully obstruct the opposite side; should such wilful obstruction by either batsman prevent a ball from being caught it is the striker who is out. Notes

- The umpire must decide whether the obstruction was "wilful" or not. The involuntary interception by a batsman while running of a throw in is not in itself an offence.
- The correct entry in the score book when a batsman is given out under this Law is "obstructing the field", and the bowler does not get the credit for the wicket.

RUN OUT

41.—Either batsman is out "run out"—if in running, or at any time, while the ball is in play, he be out of his ground, and his wicket be put down by the opposite side. If the batsmen have crossed each other, he that runs for the wicket which is put down is out; if they have not crossed, he that has left the wicket which is put down is out. But unless he attempt to run, the striker shall not be given "run out" in the circumstances stated in Law 42, even should "no ball" have been called.

Notes

 If the ball is played on to the opposite wicket, neither batsman is liable to be "run out" unless the ball has been touched by a fieldsman before the wicket is put down.

STUMPED

42.—A striker is out "stumped"—if in receiving a ball, not being a "no ball", delivered by the bowler, he be out of his ground otherwise than in attempting a run, and the wicket be put down by the wicketkeeper without the intervention of another fieldsman. Only when the ball has touched the bat or person of the striker may the wicketkeeper take it in front of the wicket for this purpose.

Note

 The striker may be "stumped" if the wicket is broken by a ball rebounding from the wicketkeeper's person.

THE WICKETKEEPER

43.—The wicketkceper shall remain wholly behind the wicket until a ball delivered by the bowler touches the bat or person of the striker, or passes the wicket, or until the striker attempts a run. Should the wicket-keeper contravene this Law, the striker shall not be out except under Laws 36, 37, 40 and 41 and then subject to Law 46.

Note

 This Law is provided to secure to the striker his right to play the ball and to guard his wicket without interference from the wicketkeeper. The striker may not be penalised if in the legitimate defence of his wicket he interferes with the wicketkeeper, except as provided for in Law 38 Note 2.

THE FIELDSMAN

44.—The fieldsman may stop the ball with any part of his person, but if he wilfully stop it otherwise, five runs shall be added to the run or runs already made; if no run has been made, five shall be scored. The penalty shall be added to the score of the striker if the ball has been struck, but otherwise to the score of byes, leg byes, no balls, or wides as the case may be.

Notes

A fieldsman must not use his cap, etc., for the purpose of fielding a ball.
 The five runs are a penalty and the batsmen do not change ends.

(e) Duties of the Umpires

45.—Before the toss for innings, the umpires shall aquaint themselves with any special regulations, and shall agree with both captains on any other conditions affecting the conduct of the match; shall satisfy themselves that the wickets are properly pitched; and shall agree, between themselves on the watch or clock to be followed during play.

- Apart from "Special Regulations" (see Law 10, Note 1), other conditions of play within the framework of the Laws are frequently necessary, e.g., Hours of Play, Intervals, etc.
- 2. The captains are entitled to know which clock or watch will be followed during play.

46.—Before and during a match the umpires shall ensure that the conduct of the game and the implements used are strictly in accordance with the Laws. They are the sole judges of fair and unfair play, and the final judges of the fitness of the ground, the weather and the light for play in the event of the decision being left to them. All disputes shall be determined by them, and if they disagree the actual state of things shall continue. The umpires shall change ends after each side has had one inning.

Notes

- An umpire should stand where he can best see any catch upon which his decision may be required. Subject to this over-riding consideration, the umpire at the bowler's end should stand where he does not interfere with either the bowler's run up or the striker's view. If the other umpire wishes to stand on the off instead of the leg side of the pitch, he should obtain the permission of the captain of the fielding side and inform the batsman.
- 2. The umpires must not allow the attitude of the players or spectators to influence their decisions under the Laws.
- A code of signals for umpires is laid down in the notes to the relevant Laws, but an umpire must call as well as signal, if necessary, to inform the players and scorers.
- 4. FAIR AND UNFAIR PLAY
 - (i) The umpires are entitled to intervene without appeal in the case of unfair play, but should not otherwise interfere with the progress of the game, except as required to do so by the Laws.
 - (ii) In the event of a player failing to comply with the instructions of an umpire or criticising his decisions, the umpires should, in the first place, request the captains to take action and, if this proves ineffective, report the incident forthwith to the executives of the of the teams taking part in the match.
 - (iii) It is illegal for a player to lift the seam of the ball in order to obtain a better hold. In such case the umpire will, if necessary, change the ball for one which has had similar wear, and will warn the captain that the practice is unfair. The use of resin, wax, etc., by bowlers is also unfair, but a bowler may dry the ball when wet on a towel or with sawdust.
 - (iv) An umpire is justified in intervening under this Law should any player of the fielding side incommode the striker by any noise or motion while he is receiving a ball.
 - (v) The umpires are justified in preventing players from causing damage to the pitch which may assist the bowlers.
 - (vi) The persistent bowling of fast, short-pitched balls at the batsman is unfair if, in the opinion of the umpire at the bowler's end, it constitutes a systematic attempt at intimidation. In such event, he must adopt the following procedure:—
 - (a) When he decides that such bowling is becoming persistent he forthwith "cautions" 'the bowler.
 - (b) If this "caution" is ineffective, he informs the captain of the fielding side and the other umpire of what has occurred.

- (c) Should the above prove ineffective, the umpire at the bowler's end must:—
 - At the first repetition, call "dead ball", when the over is regarded as completed.
 - (ii) Request the captain of the fielding side to take the bowler off forthwith.
 - (iii) Report the occurrence to the captain of the batting side as soon as an interval of play takes place.

A bowler who has been "taken off" as above may not bowl again during the same innings.

- (vii) Any attempt by the batsmen to steal a run during the bowlet's run up is unfair. Unless the bowlet throws the ball at either wicket (see Laws 26, Note 3, and 27, Note 2), the umpire should call "dead ball" as soon as the batsmen cross in any such attempt to run, after which they return to their original wickets.
- (viii) No player shall leave the field for the purpose of having a rub down or shower while play is actually in progress.

5. GROUND, WEATHER AND LIGHT

- (i) Unless agreement to the contrary is made before the start of a match, the captains (during the actual play the batsmen at the wickets may deputise for their captain) may elect to decide in regard to the fitness of the ground, weather or light for play; otherwise in the event of disagreement, the umpires are required to decide.
- (ii) Play should only be suspended when the conditions are so bad that it is unreasonable or dangerous for it to continue. The ground is unfit for play when water stands on the surface or when it is so wet or slippery as to deprive the batsmen or bowlers of a reasonable foothold, or the fieldsman of the power of free movement. Play should not be suspended merely because the grass is wet and the ball slippery.
- (iii) After any suspension of play, the captains, or, if the decision has been left to them, the umpires, unaccompanied by any of the players, will, without further instructions, carry out an inspection immediately the conditions improve, and will continue to inspect at intervals. Immediately the responsible parties decide that play is possible, they must call upon the players to resume the game

APPEALS

47.—The umpires shall not order a batsman out unless appealed to by the other side which shall be done prior to the delivery of the next ball and before "time" is called under Law 18. The umpire at the bowler's wicket shall answer appeals before the other umpire in all cases except those arising out of Laws 38 or 42 and out of Law 41 for run out at the striker's wicket. In any case in which an umpire is unable to give a decision, he shall appeal to the other umpire whose decision shall be final. *Notes*

- An appeal "How's that" covers all ways of being out (within the jurisdiction of the umpire appealed to). When either umpire has given a batsman "not out" the other umpire may answer any appeal within his jurisdiction, provided it is made in time.
- The umpire signals "out"by raising the index finger above the head. If the batsman is not out, the umpire calls "not out".
- An umpire may alter his decision provided that such alteration is made promptly.

- 4. Nothing in this Law prevents an umpire, before giving a decision, from consulting the other umpire on a point of fact which the latter may have been in a better position to observe. An umpire should not appeal to the other umpire in cases on which he could give a decision merely because he is unwilling to give that decision. If, after consultation, he is still in any doubt, the principle laid down in Law 46 applies and the decision will be in favour of the batsman.
- The umpires should intervene if satisfied that a batsman, not having been given out, has left his wicket under a misapprehension.
- 6. Under Law 25 the ball is "dead" on "over" being called: this does not invalidate an appeal made prior to the first ball of the following "over", provided the balls have not been removed by both umpires after "time" has been called.

NOTES FOR SCORERS AND UMPIRES

- 1. (a) Law 4 explains the status of the scorers in relation to the umpires.
 - (b) During the progress of the game, if two scorers have been appointed, they should frequently check the total to ensure that the score sheets agree.
 - (c) The following method of entering "no balls" and "wides' '(Laws 27 and 29) in the score sheet is recommended:---
 - (i) If no run is scored from the bat off a "no ball", the latter be entered as an "extra" and a dot placed in the bowling analysis with a circle round it to show that the ball does not count in the over.
 - (ii) If runs are scored from the bat off a "no ball" they should be credited to the striker and entered in the bowling analysis with a circle round the finger. Such runs count against the bowler in his analysis even though the ball does not count in the over.
 - (iii) All runs scored from "wide balls" are entered as "extras" and inserted in the bowler's analysis with a cross to indicate that the ball does not count in the over.

The following code of signalling between the umpires and scores has been approved:—

> Boundaries—by waving the hand from side to side. A Boundary six—by raising both arms above the head. Byes—by raising the open hand above the head.

Leg Byes-by touching a raised knee with the hand.

Wides-by extending both arms horizontally.

- No Balls-by extending one arm horizontally.
- The decision "Out"—by raising the index finger above the head. "One short"—by bending the arm upwards and by touching the top of the nearest shoulder with the tips of the fingers of one hand.

If the above instructions are properly carried out, cases of disagreements as regards the scores and the results of matches should not occur.

It is, however, important that the captains should satisfy themselves of the correctness of the scores on the conclusion of play, as errors cannot subsequently be corrected.

It should be noted that, in general, by accepting the result notified by the scorers, the captain of the losing side has thereby acquiesed in the "playing out or giving up" of the match stated in Law 22. Kindly Sponsored by .

COMPETITION BY-LAWS

29

COMPETITION TO BE IN GRADES

i .- Annual competitions shall be conducted in grades designed "A" and "B" which grades, depending upon the number of teams affiliated, shall be further subdivided, the Executive Committee having power to direct the Grading Committee as to the number of teams to be allotted in each division.

GRADING

ii.-The Grading Committee shall meet when directed by the Executive Committee and shall grade all teams and players in order of strength having regard to any direction from the Executive Committee regarding the number of teams to be included in each division. The Executive and/or the Grading Committee may at any time bar any player or players from playing in any particular grade.

REGISTRATION FORMS TO BE FURNISHED

iii.-The Secretary of each club shall lodge with the Association Secretary not less than eleven applications for registration in respect of each team not later than two weeks after the election of the Executive Committee.

PENALTY

Failure to comply with this law shall render a team liable to disqualification.

SCORER-SCOREBOOKS

iv .- Each team shall use scorebooks approved by the Association and shall provide a scorer who shall be required to record his opponent's as well as his own team's bowling analysis.

SCOREBOOKS TO BE MADE AVAILABLE

v.-Scorebooks shall be made available to the Executive Committee when required. Any club failing to do so or not keeping a proper record of each match shall be liable to a fine not exceeding ten shillings for each offence.

RESULT FORM

vi.-At the conclusion of play each day, the captain of the "home" team shall phone details of the day's play to the Recorder, and at the conclusion of the match each captain shall record details of the match on the prescribed form and post it to the Official Recorder not later than mid-day on the following Monday. Failure to do so shall render a club liable to a fine of five shillings for each offence.

TROPHY-TEAMS AND INDIVIDUAL

vii.-Providing the club is not under suspension nor in default, the team in each division with the highest pointscore at the conclusion of the competition shall be awarded a trophy, the value of which shall be assessed at the rate of ten shillings for each member who has participated in at least half the arranged number of competition matches.

viii .-- In addition to trophies awarded under by-law (vii), individual trophies of a value of not less than ten shillings each shall be awarded to the winners in each division as follows:-

Batting Average, Batting Aggregate, Bowling Average, Bowling Aggregate, All Rounder, Wicketkeeper and for the Best Kept Scorebook.

Phone: 523 1416

Provided that any player in default or under suspension at the conclusion of the competition shall forfeit all right to the award of a trophy.

Provided further that the Executive Committee reserve the right to reject all scorebooks, if considered necessary, on grounds of illegibility or incompleteness.

QUALIFICATION FOR TROPHIES

ix.—To qualify for any trophy, a player must have participated in at least half of the arranged number of matches. In addition, bowlers must have bowled not less than sixty-five overs and all-rounders must have compiled not less than 200 runs and secured not less than 25 wickets. One point shall be allowed for each ten runs and one point for each wicket.

x.—All trophies the property of the Association must be returned by 30th April each year to the Association Secretary.

xi .-- Finals, semi-finals and representative matches shall be excluded when assessing performances for trophies.

FEES

xii.--Match fees shall be £1/10/-, plus umpires' fees, per team per match, and shall be paid not later than the first council meeting after the match.

Provided that where no play takes place as the result of wet weather the fee shall be normal umpires' fees only.

Provided further that where a team forfeits at the Council or Executive meeting prior to the match, no fees shall be chargeable-forfeiting teams to pay all fees.

FLAGS AND EQUIPMENT

xiii.—The home team shall supply and fix mats, suitable flags as laid down in the rules and shall provide two sets of stumps and bails for the use of the visiting team, all such equipment to be free of defects.

xiii(a).—First-mentioned team to be home team and be responsible for laying and fixing mats, also for picking up and returning same when required.

Any club failing to do so shall be liable to a fine of an amount not exceeding five shillings for each offence or, in certain circumstances, forfeiture of the match. Continued failure to comply with the provisions of this law shall render the offending club liable to suspension.

ATTIRE

xiv.—All players shall be garbed in white or cream attire. Shorts may be worn when bowling or fielding, but no player wearing shorts shall be allowed to bat: provided that shorts will not be allowed on the field of play in representative matches.

STUDS

Players are not allowed to bat or bowl in footwear containing studs of any description.

xv.—Infringement of law (xiv) shall result in a fine of an amount not exceeding five shillings for the first offence. Continued infringement shall be dealt with by the Executive Committee as deemed fit. It shall be the duty of the umpire to warn any offender of the provisions of the rule regarding attire and footwear. If ignored, he (the umpire) shall bring the matter under notice of both captains and submit a report through his impute to the Executive.

HOURS OF PLAY

xvi,—All-day matches from 9.30 a.m. to 1.15 p.m. and 2 p.m. to 5.45 p.m. A match of two half-days' duration to be played between the hours of 2 p.m. to 5.45 p.m.; that the first and last rounds commence at 1.45 p.m. and finish at 5.30 p.m.

Any team losing a match in the manner set down in M.C.C. Law 17 shall be considered to have lost by forfeit unless the opposing team had by then established a first innings.

MOVEMENT BETWEEN GRADES

xvii.—Players registered in one grade shall not play in a lower division of his grade without the permission of the Executive Committee. A player who participates in more than two matches in a division higher than that in which he is registered shall automatically be considered registered in the higher division.

xviii.--On application being made, the Executive shall have power to re-grade any player at any time.

MISCONDUCT

xix.—An umpire or player allegedly guilty of disorderly or offensive conduct, either on or in the vicinity of the field of play whilst a match is in progress, shall be dealt with by the Executive Committee on report. Depending upon the nature of the offence the offender, if found guilty, may be—

(a) fined an amount not exceeding one pound;

- (b) suspended from membership; or
- (c) if, in the opinion of the Executive Committee, no disciplinary action was taken against the offender by his captain, penalised to the extent of having the opposing team awarded the match by forfeit.

PROTESTS

xx.—Protests on any grounds must be in writing and be in the hands of the Association Secretary within seven days of the completion of the match in question and accompanied by a fee of ten shillings, which fee shall be forfeited to the Association if the protest be deemed frivolous.

A copy of the subject matter of the protest shall be furnished to the Secretary of the team protested against and he shall be allowed seven days to state his club's claims in writing before the matter is dealt with by the Executive.

No member of the Executive shall be allowed to sit as a Disputes and Protests Committeeman on any case in which his own club is one of the parties concerned. Protests shall only be recognised if submitted by the Secretary of a Club or Umpires' League.

APPEALS

xxi.—Any Club or Member may, through the club secretary, appeal against the finding of the Executive or the severity of the finding. Appeals shall be lodged in the same manner as protests accompanied by a fee of ten shillings, which shall be forfeited to the Association if the appeal be deemed frivolous. No member of the Executive shall be allowed to sit as an Appeals Committeeman on any case which his club is one of the parties concerned. By Courtesy of

APPEALS TO N.S.W. JUNIOR CRICKET UNION

xxii.—Rule 33 of the New South Wales Junior Cricket Union Constitution provides for an appeal to that body against any decision of an Association which involves in general an interpretation of the rules of the Association or the Laws of Cricket, provided that such appeal is lodged with the Association within fourteen days of the Association's decision.

As directed by that Constitution, the provisions of Rules 33 and 34 of the Constitution of the N.S.W. Junior Cricket Union shall be incorporated in and form part of the Constitution of the Sutherland Shire Cricket Association.

SELECTION COMMITTEE

xxiii—The selection Committe referred to in Rule 42 shall consist of three members elected by the meeting. It shall be assisted by the last captains of the Association representative teams who shall be co-opted in an advisory capacity only.

In addition the Committee shall have power to co-opt other members as it thinks necessary, such members to act in an advisory capacity only.

The Selection Committee shall meet as directed by the Executive Committee for the purpose of selecting teams to represent the Association.

xxiv,—Any member who notifies the Association Secretary of his availability for representative matches and who then fails to appear after having been notified of his selection by the Association Secretary shall render himself to a fine not exceeding \$2.

Some Important Points for all Club Officials,

Managers, Coaches and Scorers

Ladies and Gentlemen,

The success of the season is in your hands. You must remember that you are in charge of young lads playing organised sport, and quite often your own conduct is taken as a guide to those under your control.

Every official, whether they be Association or Club, is working for the one cause — "BOYS' CRICKET". Treat them as friends and conduct yourself towards them as you would expect the same attitude towards yourself.

The main thing to remember if "THE GAME'S THE THING". It rises above all other considerations.

Meetings

Be regular attenders. Each club is entitled to two voting delegates. Delegates are requested to convey back to their Club Secretary all matters affecting their club in a prompt and accurate manner, thus avoiding unnecessary delay. Unless otherwise advised, Delegate Council Meetings will be held in St. Patrick's School Hall, President Avenue, Sutherland, on the Tuesday following each completed round at 8 p.m. sharp. Visitors are always welcome.

Results Sheets

To be completed in full and forwarded after each completed match to the official recorder, Mr. F. Malbon, 17 Crystal Street, Sylvania Heights or sent to Box Post Office, Sutherland, **Post early**.

Score Books:

Use only score books approved by the Association. This should show full details of both teams and signed by each controlling official at the close of each day's play.

Both teams should be declared in the book prior to commencement of play. Wicket keeper's name noted each innings. No alterations or erasions are to be made after books have been signed.

Books should be made available for inspection at any time.

Publicity

Each club has been supplied with Club Publicity Sheets. Club Publicity Officers should place the sheet before 12 noon on the Sunday following each day's play in Mr. Croucher's letter-box, 595 Princes Highway, Kirrawee, Mr. Rutty will then collect the sheets and results will appear in the local press. Don't be lazy, the lads like to see their name in the papers for meritorious efforts. Please co-operate in this aspect.

Umpiring

Ignorance of the rules of the game causes mistakes. The players suffer by mistakes. Consult the Umpires Association Secretary, Mr. C. Johnson, 229 Gannons Road, Dolans Bay — 523-5086 for details of Umpire's coaching classes and guidance. Avail yourself of this splendid opportunity to learn the rules of the game, thus giving the boys the benefit of correct umpiring, DO NOT, UNDER ANY CIRCUMSTANCES, question a fellow umpire's decision on the field of play. Study carefully the L.B.W. rule and remember, if you are in doubt, the decision must favour the batsman.

Don't let your match fees accumulate — \$1.50 per match per team, 20 cents registration for each player. No player is registered until his fee is paid. Money may be paid at meetings or cheque sent to the Treasurer. Mr. C. Taylor, 91 Burarba Road, Gymea.

Registration

Make sure with your club Secretary that all boys in your team are registered before each match commences. Playing an unregistered player will cost you the match (Rule 19).

Wet Weather: See Rule 31A and 31B

Try and forget the points table and play if at all possible, either for the full period or at least part thereof.

Matting

Matting costs a lot of money — treat this important item very carefully — sweep the pitch before laying the mats and offer every care to the mats in general.

Most mais are stored on private property. We are indebted to those people; use courtesy and care when collecting or stacking mats away. Contact the Association Secretary if any difficulty is experienced. Mats are to be taken up after late game on those wickets not used by the men's competition.

Coaching

The Association is concerned over the frequent interruptions to fixtures caused by Manager's/Coaches giving advice to bowlers and batsmen and continually altering the field. Much of it could be done in a discreet manner at the end of each over, or at a fall of wicket. General advice is: U/16's—No coaching, game in sole control of captains. U/14's—discreet advice on field placing at end of over, but game not held up. U/12's davice in general as long as game is not held up. U/10's—Manager/Coach can assist in all phases. DON'T WASTE TIME.

Draw

Study the draw closely and keep in close contact with your club secretary for any changes which may often occur in grounds or dates.

Attire

White/Cream shorts, trousers, shirts, pullovers, boots or shoes, socks. See rule 32 — Try and encourage club spirit by a club cap in the appropriate colours of the Club.

Playing Times

Start on time. For finishing time, on the 1st day finish on time irrespective of whether the over has been completed — on the second Saturday, either side can demand the final over be completed, irrespective of time or the fall of wicket.

RULES OF

SUTHERLAND SHIRE CRICKET ASSOCIATION

(BOYS' COMPETITION)

PREFACE

(a) The S.S.C.A. (Boys' Competition), hereinafter referred in the rules as such, is a competition constituted under the Sutherland Shire Cricket Association to organise, control and administer cricket for boys under the age of 16 years in the Sutherland Shire.

(b) Two nominated delegates from affiliated clubs, comprising the S.S.C.-A.B.C. and the officials of the retiring committee, shall elect their own office bearers and an Executive Committee at an annual meeting prior to the 31st July of each year.

RULES

1.—The S.S.C.A.B.C. Executive committee shall consist of the following office bearers:—President, two active Vice-Presidents (Senior and Junior), Secretary, Assistant Secretary, Treasurer, Official Recorder, Publicity Officer, Registrar, and 3 elected members from affiliated club delegates to act as their representatives on that committee. This committee shall meet when summoned by the Secretary, or upon the requisition of 3 or more of its members.

2.—The Executive committee shall be elected at an Annual Meeting to be held not later than the last day of July of each year. The retiring members and two delegates from each affiliated club shall be entitled to vote at this meeting, which shall also elect Patron or joint Patrons and Vice-Presidents.

3.—Any member of the Executive committee who shall absent himself from two consecutive association meetings shall be asked for an explanation. If deemed unsatisfactory, his seat shall be declared vacant, such vacancy to be filled by the next highest in ballot, or if necessary by an election at the first available delegates' council meeting.

4.--(a) At all delegates' councils meetings, one-third of the nominated delegates shall form a quorum.

(b) At all executive committee meetings, two-thirds of the Executive committee shall constitute a quorum.

5.—At the first meeting of the Association after the Annual or adjourned Annual Meeting, which calls for club nominations, each club desiring to affiliate shall submit on the appropriate form the names of the Secretary and Treasurer of that club, together with the names of two delegates and/or alternate delegates, with full addresses. The Association Secretary will record and register same, and conduct any further business through that nominated Secretary unless advised in writing of change of nominees.

Nominated delegates will be the only ones entitled to vote at Association meetings, unless notification in writing is received by the Association Secretary prior to the commencement of any one meeting.

6.—An affiliated club shall enjoy all the privileges of membership until the closing of club affiliations at the meeting specified in rule 5.

7.—The Executive committee shall have power to recommend to the delegates' council meeting the rejection of any application for affiliation if considered necessary, and also the dis-affiliation of any club or team provided sufficient evidence warrants such action.

8.—All clubs, upon nomination for affiliation, must lodge with the Association an amount of \$4.20, which will be held in reserve by the Association, and refunded to the affiliated club on the termination of its membership. Any amounts owing to the Association are to be deducted before any refund is made.

9.-The official colours of the Association shall be White/Sky Blue.

10.—The council delegates' meeting or the Executive committee may nominate any person as a member of a special committee, or may at any time elect a sub-committee that may be deemed necessary at the time to handle any Association matter—any such committee shall be under the control of the Executive committee, and will report their recommendations or findings to the delegates' council meeting through the Executive committee.

11.—Annual competitions shall be conducted in age groups, designated as Under 16, 14, 12, 10, which age groups depending upon the number of teams affiliated shall be further sub-divided, the Executive committee having power to direct the grading committee as to the number of teams to be allotted to each division.

12.—All registered players must be under the age of their groups, e.g., 16, 14, 12, 10 or other age groups, if applicable, on the set date as at the 1st October which commences the season.

Age must be evidenced by Birth Certificate or extract thereof, or in exceptional circumstances evidence acceptable to the Executive committee.

13.—The nominated Secretary of each club shall lodge with the Association Secretary no less than eleven applications for registration in respect to each team, such application to be on approved form existing at the time, and to be lodged at a specified date by the Executive committee. Each nomination shall bear the name of the club official/officials controlling that particular team nominated.

14.—A registration fee of 20c will be charged each player, ten cents of this fee will be allocated to the senior Association, namely the S.S.C.A., as a donation to its matting funds. No registration will be accepted without the fee. No player is eligible to play unless his registration is approved by the Executive committee.

15.—A Grading committee shall meet when directed by the Executive committee, and shall grade all teams as submitted by affiliated clubs, having regard to any direction from the Executive committee regarding the number of teams to be included in each division. The Executive/Grading committee may at any time debar any player from playing in any particular age group applying to a particular division.

16.—(a) After team nominations have been submitted to the Association and accepted and graded by the Grading committee, any player desirous of transferring from one club to another for the season under review must produce a clearance from the club he last registered with, and obtain the Executive committee's approval before playing with a different club to that at which he was orginally registered at the commencement of the season.

16.—(b) However, players may play in a higher graded team once only during a competition season without prior application to the executive committee provided the reasons are tabled in writing to the immediate delegates meeting following the fixture they played in and a notation is made on the results sheet of the match the player participated in.

17,--Transfer of players "between clubs" cease after round 7 of the competition.

18.—The Executive committee may reject the registration or transfer of any player at any time in any grade when it thinks fit.

19.—Any team playing an unregistered player or disqualified player shall be liable to lose all points for the matches which the said player took part in. Maximum points scored in the division in the round shall be awarded to all teams against whom the unregistered player played, and the offending club may be fined an amount of the match fee ruling at the time.

20.—The Secretary or Treasurer of each club may post a member of his club for default provided the said member has been given at least 7 days' notice in writing. All unfinancial teams or players must be posted not later than the 30th April each year.

21.—Any player or team upon proved to be in default shall be disqualified from taking part in competition matches until the amount of default has been satisfied. 22.—A batting fee to be determined at the adjourned Annual Meeting shall be charged for all competition fixtures. This must be paid to the Association Treasurer on or before the Association meeting followthe completion of each match. The Treasurer will announce all unfinancial teams and teams with three or more match fees in arrears shall be asked for an explanation. If such is deemed unsatisfactory, disqualification of the club may result.

23.—Any team forfeiting a match must give an explanation satisfactory to the delegates' council meeting, under penalty of possible disqualification, and shall pay same batting fees as the teams which played on that day. A team forfeiting shall be liable for the whole of the batting fees unless three days' notice has been given to the Association Secretary and also the opposing club prior to the day set down as the first day of the match.

24.—Any player, manager, umpire, or club official allegedly guilty of disorderly or offensive conduct at either on or in the vicinity of the field of play while a competition match is in progress shall be dealt with by the Executive committee on report. Depending upon the nature of the offence, the offender, if found guilty, may be—

- (1) Fined an amount not exceeding \$2.
- (2) or Suspended from membership.
- (3) If in the opinion of the Executive committee no disciplinary action was taken against the offender by his manager and the offence had a bearing on the match in progress, penalised to the extent of having the opposing team awarded a forfeit.

25.—Matters of complaint or dispute concerning games must be in the hands of the Association Secretary in writing within 7 days of the match concerned. A fee of \$1 must accompany such protest or complaint. This fee shall be retained by the Association if the matter is deemed to be frivolous. All such matters shall be investigated by a subcommittee of three elected by the Executive committee, and their findings shall be reported to the Executive committee.

26.—Any club dissatisfied by a decision conveyed by the Executive committee may appeal through its Secretary to the delegates' council meeting for a further decision. Such appeal must cover the same conditions as in Rule 25. No member of the Executive committee shall be allowed to serve on the committee during the time when the appeal is being heard if his club is one of the parties concerned. No affiliated club delegate is allowed to vote on meetings of appeal if his club is concerned in the appeal.

27.—Any club, through its Secretary, may appeal to the Sutherland Shire Cricket Association against the finding of the Association or the severity of the finding. Notice of Appeal shall be lodged in the same manner as in Rule 25, with the same accompanying fee and conditions.

28.-No match shall be postponed for picnics or any other functions.

29.--All competition matches are to be played in accordance with the rules of the S.S.C.A. Boys' Competition.

30.—All teams shall use wickets as directed by the Association, and matches must be played and completed on those wickets as set down in the draw, unless permission is granted by the Executive committee for a change of wicket.

31.—(a) If due to abnormal weather conditions prevailing on the motning of match, or if in the opinion of the Eexecutive committee that the overall state of the grounds are in a waterlogged condition, the Executive committee may instruct the Association Secretary to notify all clubs that play has been abandoned for the day, such decision to be promulgated by 7.15 a.m.

31.—(b) Unless any club has been officially notified as in Rule 31B that play has been abandoned for the day, the sole control of fitness of the ground and weather prior to the commencement of play shall rest with the opposing team manager's. If they are unable to reach a decision in agreement that play should commence on time, both teams shall be required to remain on the ground until further inspections are made. If after $\frac{1}{2}$ (half) the playing time has elapsed, e.g. (90 minutes, 3 hour fixture), 60 minutes, 2 hour fixture, and both manager's still disagree, play shall be deemed to be abandoned for the day.

32.—All players taking part in competition matches must wear white/ cream shirt, white/cream trousers or shorts, white socks, shoes or boots. No player will be allowed to bowl if wearing other than white/cream shirt or sweater, and white/cream trousers or shorts, white socks, white shoes or boots.

33.—The above rule (No. 32) also applies in representative fixtures except boys in the 16 group, who will not be allowed to wear shorts when batting or bowling.

34.—Players are not allowed to bat or bowl in competition or representative fixtures in footwear containing studs, spikes, or such like, unless it be on a turf wicket approved by the Association.

35.—Infringement of Rule 34 shall result in a fine not exceeding 50c for the first offence. Further infringements shall be dealt with by the Executive committee, who may suspend a player for any period as deemed fitting. It shall be the duties of all umpires to warn any offender of the proviso of this Rule, and not to allow any player to participate unless he conforms to same.

36.—Scorers shall be requested to keep their own score as well as their opponents' batting and bowling analysis, and umpires shall initial each score book at the completion of each innings and\$or at the cessation of play.

37.—The Executive committee shall have power to reject any score book not approved by the Association, or any book in which it considers the averages or scores have been improperly kept. They shall have the power to impose a fine and award points to either team. This recommendation shall come from the official recorder.

86

38.—Score books shall be handed in by clubs to the official recorder upon demand. Average sheets shall be completed in all detail within fourteen (14) days after the completion of the competition, and handed in. Penalty for not abiding by this rule may result in a fine of \$1 being imposed on offending teams.

39.—In all matches where a dispute on the result of the match exists, and a discrepancy appears in the score books, the books will be forwarded to the Executive committee for a decision. The Executive committee will deal with same as in Rule 25.

40.—At the conclusion of each match, both managers shall record details of the game on the prescribed result form and shall either post or deliver it to the official recorder prior to the delegates council meeting following the match. Failure to comply may render a team liable to a fine of 25c for each offence, or may result in loss of points for the match concerned. Competition points are to be withheld from the offending team until such results have been forwarded to the official recorder.

41.—(a) The home team shall be responsible for laying matting and returning same if required, provide adequate suitable flags and shall provide two sets of stumps and bails for the use of the visiting team, all to be free of defect.

41—(b). Any team failing to comply with the above shall be liable to a fine not exceeding 50c for each offence, or in certain circumstances, forfeiture of the match. Continued failure to comply with the provisions of this law shall render the offending club liable to suspension.

42.—Any registered player who is injured in the course of play, whilst participating in a match arranged by the Association shall be reimbursed to an amount not exceeding ten pounds (\$20) in respect of any one injury for medical expenses.

43.—All injuries are to be confirmed by the team manager concerned, preferably on a result form. On production of a receipted account from a legally qualified medical practitioner or hospital, if such expenses be incurred as a direct result of such injury.

44.—All balls used in competition matches shall be only those approved by the Association

45.—TEAM TROPHIES: Provided the club or team is not under suspension nor in default, the team in each division with the highest points score at the conclusion of the competition shall be declared the winner and awarded a trophy, the value of which shall be assessed by the Budget and Trophy Committee, for each member who had participated in at least half the arranged-number of competition matches. (This is subject to Rule 37 being complied with).

46.—(a) In addition to trophies under (45), individual trophies of a value assessed by the Budget and Trophy committee, shall be awarded at the discretion of the Trophy committee to each division as follows:—

latting average.	Batting aggregate.
lowling average.	Most wickets.
Wicket-keeper.	Best kept score-boo

Provided that any player in default or under suspension at the conclusion of any competition shall forfeit all rights to the award of such trophy/ trophies, and that Rule 37 has been fulfilled.

46.—(b) To qualify for any individual trophy, all players must have participated in at least half the arranged competition matches, and bowlers must have bowled 40 overs or taken 40 wickets, and batsmen must have batted in half the arranged competition matches.

47.—The Association may award any special trophies to players as they deem fit if they consider the player's performance warrants it.

48.—All trophies the property of the Association, must be returned to the Secretary of the Association in a presentable condition not later than the 30th April of each year.

49.—In the event of two teams finishing level on points at the conclusion of the competition, the Premiers will be determined by a play off. The conditions under which this match will be played will be left to the discretion of the Executive committee. In the event of no play being possible on the day or days set down, or if the match is tied or drawn, the two teams shall be declared Joint Premiers.

50.—In the event of more than two teams finishing level on points at the conclusion of the competition, the Premiers will be determined in the quotient system, which is the teams' batting average divided by the bowling average.

51.—Representative teams are entered in all competitions in all age groups, deemed fit by the Executive committee.

Representative teams consist of a maximum of 14 players, all of whom shall be present at all representative fixtures which are listed for their particular team.

Nominations for the positions of Managers. Selectors and Coaches of the representative teams should be in the Association Secretary's hands prior to or at the Executive Committee Meeting following the adjourned Annual Meeting each year. Selectors have the power to co-opt any further assistance they need in an advising capacity.

52.—Any player who notifies the Association Secretary of his availability for representative matches and who fails to appear after having been notified of his selection may render himself liable to a disqualification from all S.S.C.B.A. Fixtures.

LOCAL COMPETITION RULES AND CONDITIONS

The M.C.C. Laws of Cricket (1947 Code - 1st Edition) as amended by Council Meeting of the N.S.W. Junior Cricket Union 1/1/63 and as amended further as shown hereunder, shall apply to all matches arranged by the Association.

Further amendments are:---

53 (a).-Law 1, Note 2, by inserting after word "eleven" the words "not less than six registered."

(b)-By the addition of the following Note 3, "No team shall be allowed more than three (3) substitutes in the field."

(c)—Law 5, Note I, by the addition after the word "association" the words "but shall be provided by each team who shall have a suitable replacement in readiness."

(d)-Law 13-(1) by the addition after Note 2.

Note 3.—If a team has batted full time on the first day it shall not continue to bat on the second except if time was lost due to wet weather, when such team may continue to bat on the second for a length of time not exceeding half of that lost on the first day.

If no play takes place on the first day, the first imnings on the second day shall not continue longer than half the time remaining for play, and providing the time is evenly divided, the team scoring the most number of runs, irrespective of wickets lost shall be declared the winner, provided the recorder is satisfied regarding the number of overs, bowled by each team is in proportion.

(c)—Law No. 20, Note 2. By the addition after Note 5, the following: "The boundary line shall be imaginary straight lines between boundary flags placed by the home team at a distance not exceeding fifty feet from each other, or by other defined boundary previously approved by the Executive committee."

By the addition in place of the deleted Note 5:

Note 5. "The allowance of six runs referred to in Note 4 of this Law where the boundary is defined by a picket or similar type fence."

(f)--Note 5. Points shall be assessed as follows:-Outright win-6 points.
Win 1st Innings-4 points.
Draw or Tie-3 points.
Win or Forfeit--Highest points won by any team in same
division in same round.
Loss on 1st Innings-2 points.
division in same round.

(g)—Law 23. by deletion of Note 1, and substitution of— Note 1, subject to the other conditions of this law an over shall be considered "eight balls," and the addition of

Note 2. "In matches arranged by the Association, the Executive Committee shall, in certain circumstances, be empowered to direct that consecutive overs shall be bowled from the same wicket."


Law 7-Add the following sentence:

"Where canvas or coir matting or malthoid or similar materials is used on a pitch made of concrete or any other hard base, the width of such artificial covering shall be regarded as the width of the 'pitch' and any ball bowled and pitching off such covering on either side of it shall be held to be a 'No Ball' and the Umpires shall call and signal 'No Ball' immediately the ball so pitches."

54.—Any affiliated club desirous of having a rule altered or added to must supply full details in writing to the Annual Meeting. The Executive Committee shall also tender their recommendations for additions and/or alterations to rules.

55.—The existing rules shall not be altered (except at Annual Meetings) without the consent of 2/3 of the delegates at a General Meeting of which at least fourteen (14) days' notice in writing shall be given to each club.

Reading of the notice in writing to the previous fortnightly delegates meeting shall be considered sufficient for this purpose.
